Upon enrollment of our child/children as student(s) at Miami Baptist Church & School, we hereby agree to agree to the following terms:

- 1.) We understand that all tuition payments for the school year are due on the 5th of the month and must be received by the Finance Office **NO LATER** than the 20th of each month, or a \$25.00 late fee will be assessed. Report cards will be held at the end of each semester until all fees, including Extended Care, are paid in full. If tuition and Extended Care payments are still delinquent after the 10th of the following month, Miami Baptist Church & School reserves the right to suspend the child from classes or Extended Care until the amount is brought current, unless arrangements have been made with the Finance Office.
- 2.) We understand there will be a \$50 fee charged for any check that does not clear the bank for any reason. After a second bounced check a Cashier's Check, Money Order, or cash must be submitted to the Finance Office within 5 days to replace the check.
- 3.) Tuition is stated for the school year and may be paid in ten (10) monthly payments. For the student who enrolls or withdraws during the school year, charges, other than non-refundable fees, will be prorated on an instructional week basis. Refunds will be determined by the final day of class attendance.
- 4.) We agree to pay for any damages to or loss of school property attributable to our student(s).
- 5.) We have read the Tuition and Fees Schedule and understand the policy of Miami Baptist Church & School is to make no refund whatsoever on registration fees.
- 6.) We understand that the school reserves the right to dismiss a student who does not respect the spiritual standards of our school or does not choose to cooperate in the educational process (including rules of conduct as stated in MBC Handbook).
- 7.) We hereby invest authority in Miami Baptist Church & School to discipline this student as may be deemed necessary by the school, including but not limited to detention, suspension, or expulsion.
- 8.) We understand that the standards of Miami Baptist Church & School do not tolerate profanity, harassment, obscenity in word or action, dishonor to the Lord's name and the Word of God, or disrespect to the personnel of the school at any time.
- 9.) We will read the School Handbook (upon receipt) and will comply with those procedures as stated therein and pledge our support to the faculty and to the administration of the school.
- 10.) Our child may take part in all school activities, including school-sponsored field trips away from the school premises. We absolve and hold harmless Miami Baptist Church & School, its agents and employees, and any person acting in its stead from any liability whatsoever resulting from injury to the child away from school or on school activities, or during any school activity on the school property.
- 11.) We, as parents or legal guardians, who are accepting the challenge to "train up a child in the way he should go" (Proverbs 22:6), do state that this training will be carried on in our home, and we shall place our trust in Miami Baptist Church & School to be an extension of that training.
- 12.) We, as parents or legal guardians of this student(s) do give our pledge to all items as stated above.
